At this time, this contest is for United States Residents only.

Video submissions must be received by July 1st, 2010 (the earlier, the better, for maximum voting time). Create a 1-2 minute video (max), explaining why you believe you are the Ultimate Horror Fan. You may use any type of camera, as long as the finished product fits the formatting rules\*. Remember, the more creative, the better. And, please remember to be respectful of the general public when filming. At no time, should anything you're doing bring physical or emotional harm to anyone else (with or without their permission). If your project appears to include any illegal activities, you will be automatically disqualified. Be artistic and smart. Winner will be notified and results, posted on the Big Bear Horror Film Festival (BBHFF) website by July 15th, 2010.

Upon winning, the UHF will be invited to serve the BBHFF as a guest judge. Films will need to be viewed and scored within the timeframe and guidelines provided at the time the winner is notified. Best of luck to you!

### Suggested topics for your video:

1. Show off your horror film trivia knowledge
2. Expose of your horror film memorabilia
3. Make a mini-horror film
4. Have someone interview you to explain why you should be chosen as a guest judge
5. Man-on-the-street interviews, with you dressed as a horror icon
